MAJOR STEPS OF THE PROJECT

I. Context, concepts, models

Understanding context and concepts in each country to identify SE models and to describe their
institutional trajectories. Country studies published as ICSEM Working papers (all available at
<http://www.iap-socent.be/icsem-working-papers>).

II. Building up an international database on social enterprise

On the basis of a common questionnaire, collection of data about over 700 social enterprises emblematic
of the SE models identified in the first stage, with a view to strengthening international comparative
analysis and to proposing a worldwide typology of SE models.

**III. Comparative analysis of SE models within world regions and at the global
level**

Publications (special issues and books) combining country-level information from previous stages,
statistical work on key SE features as well as transversal analysis of some issues such as
institutionalisation of SE models.




